7. ABW Lot 21 update:

a. Yoder reported the District is waiting for final legal documents transferring infrastructure, and easements to TMWSD. Warranty and performance bonds are in-place. Piping as-builts have been received.

8. Managers and Operations Report:

- b. Yoder has placed an advertisement in local papers, Granby workforce, and online at Colorado Rural Water Association. The Operator position is open until filled.

- d. Grand Enclave water rights purchase from TMWSD is on hold dependent on possible purchase from VWP.
- e. Yoder is working with District consultants to develop a draft O&M agreement for stake holders of PCV Reservoir and the Pearl ditch.

- a. Yoder reported Tabernash fireline meter vault and piping is installed. Waiting for the meter to arrive to finalize the installation.
- b. The annual Substitute Water Supply Plan has been filed with Division 5.
